# THE CHANNEL ISLANDS, A SAFE ENGLISH CROWN PORT-IN-A-STORM FOR HUGUENOTS



The Channel Islands, which are located off the northern coast of France, specifically Normandy, were a key "safe port in a storm" for French Protestants who fled from their homes in response to harsh royal edicts and the dragonnades, or both. Falling under the umbrella of the British Crown, they were particularly appealing because they were closer than England, yet also solidly Calvinistic Protestant. We know the Channel Islands must have also offered some special attractive mystique because, in 1883, the famous Impressionist painter, Auguste Renoir, chose to spend time there; hence, the choice of one of his paintings about the islands for our cover.

The islands accepted increasing numbers of Huguenot immigrants during the mid-1500s. There, the Huguenots were permitted to live a traditional Huguenot lifestyle as dictated by Jean Calvin in Geneva. While in the Channel Islands, and particularly in Jersey and Guernsey, Huguenots contributed to their community, especially through the development of a new knitware industry which became an important component of the international wool trade. We are fortunate to present Genealogist General Nancy Wright Brennan's informative article about researching one's Huguenot ancestors from the Channel Islands, which appears later in this issue.

Charles Baird and other historians have advised us that many of the Huguenots from the seaport towns of western France, such as La Tremblade, La Rochelle, Saintonge, Aunis, Poitou, chose to escape to the Channel Islands and that some later made their way toward England, Rotterdam and other ports of safety.

In fact, the western seaport towns of France drew suffering Huguenots from the central regions of France like a magnet; they traveled across France to one of the western French seaport towns as step one of their long and secretive "journey" (a euphemism for the word "escape") out of France. The Huguenot Society of London wrote about the western France region back in 1912, as follows:

This remote district of marsh and island is the birthplace and cradle of the Reformation in Saintonge, and because of the remoteness and inaccessibility of the Arvert peninsula, the protection of the marshes, and the freedom of the sea, the resistance of its Protestantism was unbroken, and from the early days of Reformation to the Revolution, no part of Saintonge and Poitou was so constant to the faith, while from the creeks of Arvert and Marennes, fugitives were able to were able to find means of escape, which were barred to them in the large seaports of Bordeaux and La Rochelle. When once the dragoons and the marechaussee the latter not always so eager to capture them were evaded, the refugees found ready helpers in the freemen of the sea.

Many of the Huguenots who later chose to leave the Channel Islands for greener pastures tended to to settle permanently in western and southern England because of pre-existing commercial ties with the ports there, including Bristol, Plymouth, Stonehouse and Southampton. These long-established business relationships presented opportunities to earn a living and thus eased their passage out of the probably-quieter life in the Channel Islands.

Southampton, England, was a particular favorite of Huguenots, in large part because it was already on a major trade route for the international wool trade, its citizens spoke a French dialect familiar to Huguenots (in addition to English), and its "French House" there readily took them in. Moreover, Southampton's French House offered Francophone services for Huguenots, and raised financial assistance to aid the less fortunate Huguenots who needed it. To earn a living, Southampton offered opportunities for trade with the Channel Islands and other international trading seaports.

Huguenot surnames to be found in the Channel Islands either temporarily or permanently include Guérin, Gosset, Philip English, John Touzell, John Browne, Nicolas Chevalier, Peter Morrall, John Vouden, the Cabots, Augustine, Roy, Gano, Vincent and more. Again, look for Nancy Brennan's article later in this issue, which offers significant information and tips on researching Huguenots in the Channel Islands.

# **OFFICER REPORTS**

#### **President General**

I am grateful and thankful for the opportunity to serve as President General. How are we doing?

#### 1. Manage the Transition Through the Bylaw Changes

- a. Transition has gone well.
- b. A growth plan for 2025 is in place and we have started to advertise.
- c. Simplifying the Bylaws continues, and the revision of the NHS Standing Rules is progressing.

#### 2. Maintain Rituals and Traditions

As reported in April and October 2024 there have been and will continue to be:

- a. No Ritual Changes
- b. No influx of other religions
- c. No changes in our talking points

Rituals remain an integral part of our meetings, alongside discussions of the seven Protestants and Catholic wars. These serve as valuable outreach opportunities. The 3rd Vice President General and the Registrar General will provide detailed updates on our membership status.

#### 3. Improved Communications.

We have seen mixed results

- a. Reformatted the monthly newsletter has been a struggle. We have fallen in this area.
- b. The State President's Training Program will continue. We did not do a training class in January as we did in 2024. We have delayed it for new state administrations installed in February May to step forward. The training will occur in late May 2025.
- c. There will be a Member-At-Large Meeting via Zoom in late May 2025 and hopefully an additional one in the fall of 2025.

#### 4. National Huguenot Documented Information Portal

The National Huguenot Documented Information Portal is now operational. This was made possible from the nonprofit grant from Microsoft. No action has occurred because of the President General's professional work schedule. We are still having issues with MAC and iPad general officers gaining access.

#### 5. Transition of Insignia Operations

Transition of the insignia operation is complete. Members can order online via the website or via check. City Pride Ltd is the provider for all insignia. Everything is postpaid and ships Priority 2 day once completed, however, lead times are running 4 months. See additional details in the Insignia report. The Past State President of the Huguenot Society of Florida became available for purchase November 1. Additional details are in the Insignia report.

#### 6. Huguenot Park Partnership - Fort Caroline

- 7. **Books for Kids Program** I had identified *Book Trust: Spreading the Joy of Reading Book Trust.* We were ready to forward with information to the Board of General Officers, Treasure General, and the Finance Committee for review, however, there was substantial pushback to cancel the project. Members only want to support Huguenot only projects. Some felt they do not/did not want to support projects that can/could be considered a "political project". This included the fact that most Huguenot families that came to the colonies and other locations "as reading families" because reading the Bible was so important to the culture.
- 8. Refurbishing the Huguenot section of the DAR library

This is on hold. There is no communication with / from the DAR Library on the NHS contract. This project is being spearheaded by Cathy Paunov and Joyce Patton. We do not have a copy of the contract, we have seen a copy of the contract at the DAR, but we have not been able to get them to give us a copy of the contract and we know that the contract has expired.

#### **Registrar General**

January 1, 2025 thru March 31, 2025

Since 1 January:

- 17 New Member Applications have been approved, including 2 Junior members.
- Three (3) members from Indiana have transferred to Member at Large and 5 members from Kentucky have transferred.
- Two (2) members have been reinstated and 4 supplementals have been approved.
- 12 Members have been reported deceased on the End of Year state reports or directly to the Registrar General.

The current Member Count stands at 1,278. This number includes:

- Members in KY (40) and IN (26) who have not requested transfers and may ultimately be lost with the state societies disbanding;
- States reported that 14 members resigned and 82 members dropped as of the end of 2024;
- I have made 36 Address changes;
- Responded to 75 Membership and Research Queries;
- Two queries about the NHS Scholarships are resulting in 3 new member applications from the interested fathers and sons
- Deposited Dues& Fees
- Store Sales totaled: \$2,724.00.
- Three (3) store items have been sold, packaged and mailed, including 1 Huguenot Tie, 1 Huguenot Scarf and 1 2016 Consolidated Update to the 2012 RQHA
- Mailed two State President pins sold by the Insignia Committee

We are completely sold out of the 2012 RQHA and the 2020 Update. The 2025 Register of Qualified Huguenot Ancestors is in the final stages of editing and formatting.

TX DAR also offered NHS a table to present our organization to visitors at the Conference. # NHS FINANCE COMMITTEE REPORT

## for the Six Months, Ending June 30, 2025


The financial markets rebounded during the second quarter of 2025, strengthening the finances of the National Huguenot Society. Below is a summary of key financial developments through the first half of the year. The Finance Committee is dedicated to collaborating with the Treasurer General to prepare financial reports each quarter, highlighting year-to-date results. We are pleased to outline major developments for the quarter.


Since the end of last year, the Society's overall resources have increased by 3.9% to \$718,973. This includes a 4.0% increase in our Scholarship reserve to \$355,879, a 3.3% increase in our General Purpose endowed reserves to \$40,149, and a 3.8% increase in our unencumbered reserves to \$322,258.

The operating results of the Society reflect the continued sound treasury management of our Treasurer General and are detailed in a separate submission by the Treasurer General. Financial activities have expanded for ongoing programs, including the Lois Leffler Walker Scholarship Assist fund. The Scholarship Fund was the recipient of gifts from our members. The Scholarship Committee has expanded the use of the General Scholarship Fund to reflect the protocols of the Lois Lefler Walker Scholarship Assist Fund, making several awards of \$500 each. Accordingly, we have renamed the General Scholarship Fund the Huguenot Student Resource Fund.

The Society continues to maintain strong reserves to support its long-term operations and mission. While the equity market performed poorly in the first quarter, it rebounded in the second quarter of the year, however, the broader economy and financial markets continue to face an unusual level of uncertainty. Primary concerns include:

- The administration's fiscal policies and debt management
- Its tariff policies,
- A slowdown in corporate and consumer spending,
- The Federal Reserve's ability to sustain economic growth while keeping inflation low.

We anticipate that the investment environment will continue to reflect these economic challenges throughout the remainder of the year. The rising risk of an economic slowdown coupled with elevated inflation presents a dilemma for both the Federal Reserve and investors.

Our investments are within the limits of our investment policy, with a lower allocation to equities, compared to our policy target of 40%. For fixed income and short term, we are above our policy target.

We plan to maintain fixed income allocations above target levels as interest rates are expected to decline further. Currently, 8% of our fixed income holdings are protected against unexpected inflation increases. Given continued uncertainty in global markets, we are holding our asset allocation steady.

The committee has not met formally since Oct 2024; however, we answered questions on how to wear insignia and continued work on specifications. The insignia guidebook has been on hold.

We have a few items on hand, but 99% of items are made to order coming directly from City Pride. The only issue we have with City Pride is lead time. Current lead time is 4 months. They attribute this to their make-to-order and the high volumes for Christmas and Heritage Fortnight. NHS members and the committee find this unacceptable. Jo Lee approached both Cathy Paunov, Treasurer General, and Joel Strauch, Finance Committee Chair, to determine if it was feasible to keep a few items in stock ourselves. They agreed, with continued discussions to follow. We are keeping a few mini-insignia, as this is our biggest seller. We may add additional unengraved items which are to-be-determined.

We have no NHS logo charms aka the "Pamela Wright Charm" remaining. It was determined at Mid-year not to order any more of the "Pamela Wright Charm" and the Insignia committee was charged to modify the existing logo. *More to follow in our future reports*.

November 1, 2024, the Society started accepting orders for the new Past State President's Pin. The pin is large [ $\sim 2$ " x 1"] and is \$75.00, postage and clear presentation box included. The stock is maintained at the San Antonio office and the vendor is Pin Center out of Las Vegas, NV.

#### **Publications Committee**

The Publications Committee currently consists of the Registrar General Katherine Totten, Genealogist General Nancy Brennan, and myself as Chair & Editor of *The Cross of Languedoc*. We have been industriously augmenting, revising, and otherwise preparing and finalizing the upcoming 2025 Register of Qualified Huguenot Ancestors, and it currently stands at about 800 pages long. We hope, but cannot promise, to keep the price to \$100 or less and to offer a discount to our members purchasing through the San Antonio Office. Alas, however, final pricing details must await the final page count before calculations are possible.

In the past 18 months since I retired from full time work, almost no day has passed without our committee working to clarify details and supplement the RQHA with helpful information, going further than in our past publications to identify even more of the numerous intermarriages and interconnections of Huguenot families, and to mark the cases where more proof is needed. Nancy and Kathy, along with our dearly departed former Registrar General, William Collins Buell V, have identified several new Primary Ancestors, and we have collaborated to prepare accurate revised ancestor entries for several existing Primary Ancestors' entries. Our **People Index** has been updated and expanded to constitute a thorough index of our members' Huguenot ancestors, descendants, and their inner circle. And, thanks to Nancy Brennan, we've flagged those Huguenots who have been officially recognized as **Patriots** in the Revolutionary War, plus have noted several who have not yet been confirmed. All flagged Huguenots appear in the **People Index** and also in a separate **Huguenot Patriots Index**. But the biggest new feature in the 2025 Edition is a **Place Names Index** of the countries, cities, counties & towns referenced in each of our ancestor entries, which offers a new perspective of the history and journey of our ancestors.

Overall, your Editor has compiled more than 36,000 index entries in our 3 indexes, perhaps explaining why the book has taken so long to finalize for publication. Rest assured, however, that we are in the final stages of proofing and adding maps, and then we'll publish. The book *should* be ready for publication sometime in late July or August, at which time we will issue an announcement along with pertinent purchasing information.

# **Scholarly Works Committee**

One of the Co-Chairmen and a member of the Scholarly Works Committee resigned the first of 2025. Therefore, President General Jo Lee Potts asked Peggy Stottmann of Florida to be on the committee, for which this chairman is thankful. We were unable to secure others to help with the selection of a winner for the 2024 Scholarly Works Award.

Three books were reviewed. One, LEGACIES ON THE LAND: Historic Houses, Hamlets, and Landscapes of Southern Ulster County edited by Vals Osborne, is a beautiful book. It showcases historic houses, hamlets, and landscapes of southern Ulster County, New York. New Paltz, New York is where numerous Huguenots made their homes after arriving in the Colonies. We dismissed it as a candidate because of a lack of Huguenot content, which left the two contenders.

A PEDDLER'S TALE: Religious Exile and Community in Early Modern Switzerland, by Kristine Wirts and published by the LSU Press is of interest. Jean Giraud, a Huguenot businessman from La Grave in the French Alps, is the central figure. He wrote in his *livre la raison*, an account book, information concerning the times and his flight to Vevey, Switzerland. Wirts wove a story from the gleanings of his livre and included other references to support her conclusions.

THE WAR OF THE CAMISARDS (1702-1704): Huguenot Insurrection during the Reign of Louis XIV, by Stephen M. Davis is about the last of the French Wars of Religion. Little is known about this bloody war in the Cevennes and this group of Huguenots called the Camisards. Davis gives an interesting background of the conflict and the plight of these simple Huguenot peasants armed almost solely with farming tools in their fight for freedom of conscience and religion as their desire to defend their faith drove them to offense.

In trying to pick out a winner the question of what the criteria should be in the selection came up. We agreed that there needs to be some clarification here. Based on what we discussed, the Scholarly Works Committee recommends that THE WAR OF THE CAMISARDS, published in 2024, be selected for the Scholarly Works Award.



# THE JOY IS IN THE JOURNEY -

# How Personality Types Shape Where We Go and How We Got Here

My parents could not have been more different and neither could their families.

My father wanted to be an extravert, but he was stiff, reserved and stoic. My mother was a natural extrovert. She had a big, warm smile, with a natural outgoing personality. She rounded out my father's rough edges.

My father's family, yes most of them were very blunt. No sugar coating. If they were happy, you knew it. If they were mad, you knew it. If you were the reason they were angry, God bless you. They were immediately angry; run, here came Thor's hammer and you knew why. Conflict, not a problem. Conflict resolution, another story.

By comparison mom's family, who knew. Happy all the time, even when they were mad. You might be able to tell when they were mad if and when their faces turned red and steam rolling out their ears. They avoided conflict at all costs. There was no issue leaving the scene of the crime with you scratching your head and wondering what happened. At some point in time, you may or may not have been told two, five, ten years later. Yes the joy is in the journey and the grudge.

When I look at the contrast over 48 years of research, it helps explain some of the stark differences in the family careers. My father's family were primarily farmers for more than 400 years. When they got angry they could tell their spouse, children, or chickens, after the bridge burning with relatively few consequences. By comparison, Mom's family who were more public facing careers, attorneys, crafts persons, watchmakers, blacksmiths, and painters would have suffered greatly from a blunt behavior. Were the DNA behavior traits learned or in their personalities by carrier selection? The public facing carrier choices could have had greater ramifications from bad behavior. The joy would not have been in the journey.

Having these two widely different types of DNA in our mix did not necessarily serve us well growing up. Which side do you chose growing up and how do you mix them or do you? The joy is not necessarily in the journey.

A cousin asked me a couple of days ago a question I had never been asked. "When did you know you would be hooked into genealogy?" I had never been asked that question and my response was simple. "I didn't know I was hooked until my ancestors started coming to me." My cousin looked perplexed. "The joy was in the journey." It started out to keep two promises to my Dad and to prove family stories true or false. Then the search became more and turned into a game. I met great people who become lifelong friends. I checked things off my bucket list items. I added items to the list. The game became more of what I could do instead of what I did. I was not there yet.

Family genealogy chose me. About a decade and a half ago there was an older lady in our Huguenot chapter who told me her biggest research secret for success, after I shared my biggest frustration concerning a brick wall. She said, "Dear, at this level, you have been chosen. You're working too hard. Some ancestors you will never find. You don't find your ancestors who don't want to be found. Your ancestors find you. The joy is in the journey. When your ancestors are ready to be found they will find you." I took a step back. Over the years, she has been 100% correct.

Many times, I have found things when I wasn't looking. My genealogy journey has taken me places, introduced me to people, and exposed me to experiences unimaginable to the 16-year-old who made and kept two promises to her Dad. Yes the joy truly is in the journey.

As your Huguenot Cousin, let me ask you, "Did you choose this lifestyle, hobby, career, or path or did it choose you?" What are the most joyful moments is in your journey. Has it been the hunt or the sharing? How has it impacted you and made you smile or giggle? How have personalities impacted family choice and career? Appreciate and make the most of every aspect of your journey and enjoy the ride.

Your officer has been pleased to say that he has accomplished the following since his last report. These fall within my office responsibilities as outlined in the Society's bylaws.



# College and Postgraduate Student Scholarships Offered by NHS

Thanks to several generous bequests, the National Huguenot Society (NHS) currently offers two merit scholarships for undergraduate and graduate studies. The Jacqueline Wells Dickey Scholarship is available to NHS members *only*; the Lois Lefler Walker Scholarship Assist Fund award is available to members as well as children/grandchildren of NHS members. Applications for both Scholarships are available below.

#### The Jacqueline Wells Dickey Scholarship Fund

- The late Jacqueline Wells Dickey's bequest has permitted the National Huguenot Society to offer scholarships since 2002.
- Applications, available on the NHS website, are due on February 1, prior to the commencement of the academic year for which the award is granted.
- The recipient must be a member of The National Huguenot Society, Inc. (meeting all requirements for that membership).
- The recipient must be a student at an accredited college or graduate school who has had at least two semesters of history which include, in part, history of religion.
- The recipient must have completed at least two years of college, maintaining a 3.0 average.
- Scholarships are limited to \$5,000 per student. Scholarships are not renewable.
- Need is not a factor.
- All applicants for the Jacqueline Wells Dickey Scholarship are also considered for the Lois Lefler Walker Scholarship Assist award. However, the winner of the Jacqueline Wells Dickey Scholarship is not eligible to receive a Lois Lefler Walker Scholarship Assist Fund award in the same grant year.

#### The Lois Lefler Walker Scholarship Assist Fund

- The Lois Lefler Walker Scholarship Assist Fund, created in 1986 by Sterling M. Lefler and originally administered by the Huguenot Society of Connecticut (currently inactive), is now administered by the national Society. The bequest was originally intended to assist "worthy Huguenot students in college who are direct descendants of a Society member with the purchase of textbooks." The terms of the bequest allow funds to be granted to children or grandchildren of current NHS members.
- Applications, available on the NHS website, are due on February 1, prior to the commencement of

- the academic year for which the award is granted.
- The recipient(s) must be enrolled as either a returning undergraduate or graduate student at an accredited college or university. Applications are due on February 1, prior to the commencement of the academic year for which the award is granted.
- The grant for each recipient of the Lois Lefler Walker Scholarship Assist fund is limited to a maximum of \$500 per year. Grants may be awarded to several recipients each year. A student may receive this award more than one year, but a new application is required for each year.
- Need is not a factor.
- Scholarship checks will be issued directly to educational institutions.
- Winning the National Huguenot Society's Lois Lefler Walker Scholarship Assist award does not preclude the winner(s) from subsequently applying or reapplying for the Jacqueline Wells Dickey Scholarship Fund award. All applicants for the Jacqueline Wells Dickey Scholarship are also considered for the Lois Lefler Walker Scholarship Assist award.

These application forms must be completed and submitted together with all the attachments specified in the instructions and mailed as a package to the individual identified at the bottom of the application form. 


# CHECK OUT THIS HANDY NEW REFERENCE BOOK

The Complete Guide to LINEAGE SOCIETIES: The Who, What, Where, and How,


As most of us are aware, each lineage society requires PROOF of one's lineage, something that, due to wars and the passage of time, may present a gap or other conundrums to the researcher. Dr. Nagy's book provides a discussion of how to join a lineage society, the types of proof necessary to successfully apply to a lineage society, and the application process required. Dr. Nagy's analysis will guide purposeful genealogical research, providing valuble insights regarding the identification, possible locations and comprehension of the key genealogical records needed in order to support an application to a lineage society. Like Dr. Nagy, all of us have derived much personal satisfaction by affiliating with one or more lineage societies, our interest having been unwittingly yet permanently captured as we were researching our family tree. Joining a hereditary society offers a unique and incomparable depth and meaning to one's perspective of world history and American history, and also of one's individual ancestry. The 80-page Guide is small enough to easily tuck into a briefcase or handbag and use it while visiting genealogical libraries for your research. Its value is in preparing one to effectively conduct the necessary research, properly prepare the application, and then successfully join one or more of these worthy organizations. # A PLETHORA OF HUGUENOTS YET TO BE PROVEN

The extensive 2025 Register of Qualified Huguenot Ancestors of The National Huguenot Society contains close to 700 Huguenot ancestors. About half of those have been proven by application. Some ancestors have many descendants; others have just a few. Many conscientious researchers have diligently proved new Huguenots. There are many more to be discovered.

Due to a query from a person who thought he might have an Huguenot ancestor, a new and interesting resource was discovered, which is revealing a gold mine of possible Huguenots. One of the ancestors mentioned in the query was identified as having roots in the Isle of Jersey, which led to the references listed in the 2012 Register of the identified Huguenots who had settled in one of the Channel Islands. Nicolas Effard, Jean Gosset, Louis Paisant/Paysant, Vincent Rongnion/Runyon/Runyan, and Simon Rivoire/Revere are qualified ancestors with member descendants. Rev. Pierre de Caumont, Jacques Guillet, Nicholas Le/LaGrove/LeGrou, Pierre Garcelon and Pierre Tourgée/Tourjée/Torge are proven ancestors with no NHS member descendants. A consistent source for these Huguenots is *The Quiet Adventurers in North America* by Marion G. Turk.

Investigating this source led to an unlimited number of Huguenots. According to Turk, "The [Channel] Islands, during the 1700s were nearly inundated at times with the number of Huguenots fleeing from French persecution". The author lists some of the thousands of Huguenot surnames with Channel Island connection, some of whom were established there for over a century.

Most Huguenots stayed for short periods of time before heading for Ireland, Scotland and colonies in North America. Other Huguenots had arrived in the Islands in the 1500s.<sup>3</sup>

The seven inhabited Channel Islands are in the Bay of Mont St. Michel between the French Provinces of Normandy and Brittany. They are British Crown Dependencies but are not part of the United Kingdom. Bailiwick of Jersey is the largest of the islands. It is divided into twelve parishes which are named after their parish church. St. Helier is the capital of Jersey and is the most populous. The Parish Church of St Helier is the parish church of the [town] of Saint Helier, capital of Jersey. In 1548 Edward VI ordered the destruction of all aspects of Popish Superstition within the churches of his realm. The Jerseymen, strongly influenced by Huguenot immigrants fleeing persecution in France, carried out the King's orders.

The parish church is known as the Town Church and is the oldest building in St Helier. After the Reformation, the church became a Huguenot temple, and eight successive Rectors were French Huguenot ministers. <sup>7</sup> One of those, Nicolas Effard, was installed as the rector of St. Saviour in Jersey on 25 March 1587. <sup>8</sup> "Kings Majesties rents & revenues in 1607: St Saviour "Pentions. Nicollas Effart, Minister of the Parish oweth yearly for the pentions of his benefice, payable at two termes of the year, by equall portions (viz) at Easter & Michaelmas, per annum 13 escus 10 sols". <sup>9</sup>

Jacques I Guillet and Louis Philippe Paisant/ Paysant's children were all baptized at St. Helier Church Isle of Jersey. Doth of these "Primary Ancestors" from the Channel Islands are included among the approximately 659 "Primary Ancestors" in the upcoming 2025 REGISTER OF QUALIFIED HUGUENOT ANCESTORS. In the RQHA, Primary Ancestors are going to appear using a unique display typeface and color, so that they will be easily identified in the People Index.

The upcoming 2025 NHS Register of Qualified Huguenot Ancestors currently lists a number of Channel Island Primary Ancestors and descendants, but they are relatively few in number as compared to the list of Turk's eligible families, such as De Faye, Duchemin, Hemery, St. Croix, to name only a few. <sup>11</sup>

Whether any of your Huguenot ancestors may have stayed a time in the Channel Islands should be explored by genealogical researchers. Vast sources for Channel Island ancestors include:

## Some of Those Channel Island Huguenots Who Came to America

# Salem

Ammon Stapleton, in *Memorials of the Huguenots in America: With Special Reference to Their Emigration to Pennsylvania*, informs us of the following regarding many of the Channel Islands Huguenots who decided to move onwards to America:

Among the earliest arrivals of Huguenots in New England were a number of families who settled in Salem perhaps as early as 1660. They were, for the most part, from the Channel Islands, whither they had fled from France. In 1662 Dr. John Touton, of La Rochelle, France, directed a petition to the Governor of Massachusetts for permission for himself and a large number of others who were expelled because of their religion to settle in that Province. This petition was favorably received and we accordingly find that a considerable influx of refugees took place.

In 1680 agents from La Rochelle arrived in Boston to gain permission and make arrangements for the settlement of their persecuted people there, and during the next few years, many families arrived in an utterly destitute condition; by 1682, it was necessary to take up collections in the churches for their benefit.

When finally the Revocation of the Edict of Nantes (1685) extinguished the last vestige of their civil and religious rights, a very large number, aggregating hundreds, came to Boston, prior to 1690. From this point many scattered to various colonies.

# The Tale of Joseph Roy of St. Aubin, Jersey, Immigrant to Boston and New Jersey

By Charles Baird, in History of the Huguenot Emigration to America v2, at 193, citing William B. Sprague, D.D., *Annals of the American Pulpit* v6 at 62 (1860). [The following is an excerpt:]

Joseph Roy is a Huguenot who settled in Boston after having first fled to the Isle of Jersey. He remained 11 years in Boston, and then removed to Woodbridge, New Jersey. His family finally settled in Basking Ridge, New Jersey, where five generations have lived ever since (as of the mid-1800s when Charles Baird wrote this passage).

Francis Gerneaux escaped to the Isle of Guernsey during the bloody persecution that arose in consequence of the Revocation of the Edict of Nantes. One of his neighbors having been martyred, a faithful servant of his deceased friend informed him that he himself had been doomed to the same fate, and that he was to suffer that very nigh, at twelve o'clock. Being a gentleman of wealth, and having trusworthy and influential friends around him, he at once secured a vessel and, having caused his family to be placed on board, he was himself conveyed in a hogshead to the same retreat. Before morning, the vessel was not to be seen from the harbor.

Mindful of the condition of other persons at other Protestant settlements he so managed as to send his boat ashore at several of those places and by this means his company of emigrants was much enlarged. They sailed for America, and arrived safely at New York. Mr. Gerneau died at the extraordinary age of 103 years. His surname was corrupted over the years to become Gano.
